



The Impacts of Gun Violence are Widespread

- 48,000 shot and killed.¹
- 70,000-80,000 injured.²
- One in six U.S. adults have witnessed a shooting.³
- One in five report a family member was killed by firearm.³
- Guns are the leading cause of death for children ages 0-19.¹
- Mass shootings make up a small portion (1%) of gun deaths but have wide impact.^{4,5}








48,830 lives were lost to gun violence in 2021¹

Someone was killed by a gun every 11 minutes




Firearm Deaths Over Time¹






Lethality of Guns Drive High Levels of Suicides and Homicides

81% of homicides by gun, 2021¹



55% of suicides by gun, 2021¹



 The U.S. has comparable levels of violence to other high-income countries, but a homicide rate 7.5 times higher.⁶

 85-90% of suicide attempts by firearm are fatal; other commonly used methods like poison or cutting are far less lethal ~ 5%.⁷



Gun Access Increases the Risk of Violence

- A gun in the home increases the chances of someone dying in the home by:
 - Doubling the risk for homicide.⁸
 - Tripling the suicide risk.⁸
- A woman is 5 times more likely to be murdered when her abuser has access to a gun.⁹

Gun Death Rates by Race/Ethnicity, 2021.¹


- Gun homicides disproportionately impact Black people.
- Gun suicides disproportionately impact White and American Indians.
- Men are at far high risk for all forms of gun violence.





Gun Suicide Risk

- Rural counties have a gun suicide rate twice as high as urban counties.
- White men make up 29% of the population but 70% of all suicide decedents.
- Handgun ownership increases risk of suicide by 3.3 times among men and 7.1 among females.¹⁰






Addressing Gun Suicide

- Lethal means safety counseling discussing gun safety with patients
 - Storing guns locked.
 - Storing guns outside of the home when someone is in crisis.
- Extreme Risk Protection Orders (Red flag laws)
 - Considers evidence of clear behavioral risk factors, not based on a mental health diagnosis.
 - 10-20 orders issued, one suicide prevented.¹¹
 - Widespread support 76% of Americans support.¹²
 - Emerging evidence that ERPOs prevent mass shootings, interpersonal violence.¹¹



Community Gun Violence



- Major driver of health disparities, life expectancy gap.¹³
- Black males ages 15-34 make up 2% of the population but 36% of all gun homicides.¹
- Highly concentrated in disadvantaged communities and among small networks of individuals caught in cycles of violence.¹⁴



Conditions That Facilitate Community Violence

- Deep structural inequities rooted in racism drive community gun violence.
- Community gun violence further perpetuates the cycles of concentrated poverty, structural disadvantage, and poor health.





Uneven Distribution of Gun Assault

New Orleans, 2015-2022¹⁵

- Low levels in wealthy neighborhoods.
 - Median household income \$75-100k.
 - 70% of adults with college degree.¹⁷
- Extremely high levels in the most disadvantaged neighborhoods.



Gun violence is Highly Concentrated in the Most Disadvantaged Communities

Exposure to gun violence is linked to:¹⁷

Post-traumatic stress disorder

Antisocial behavior

Depression

Stunted cognitive and emotional development

Risky alcohol and substance use

High rates of chronic disease

Increased likelihood in engaging in violence



Community Violence Intervention (CVI) Programs

- Interrupt cycles of violence, address trauma, provide community supports, and employment by:
 - Identifying the small number of individuals involved in violence.
 - Building trusting relationships through credible messengers.
 - Leveraging city resources.
 - Tailoring the program to meet the unique needs of the community.



Effective CVI Programs

- Violence interrupter programs, Cure Violence
 - 23% reduction in shootings and homicides in Baltimore program areas.
- Focused deterrence/Group Violence Intervention
 - Systematic review 30% reduction when properly implemented.¹⁹
- Programs that use cognitive behavioral interventions with wraparound supports
 - Readi Chicago, Advance Peace sustained reductions in violence and improved outcomes among participants, cost effective.²⁰
