## WHY WERE SPECIALTY TREATMENT COURTS CREATED?

- 85% of those incarcerated are substance involved.
- The US makes up 5% of the world's population but consume 2/3 of the world's drugs.
- Judges began to recognize the problem is treatable.
- Provide intensive SUD Treatment as an alternative to incarceration for non-violent offenders.
- The results were remarkable.

#### WHAT IS A SPECIALTY COURT?

- Thereputic Jurisprudence
- Treatment courts divert non-violent offenders with SUD from incarceration into supervised programs with treatment and standards of accountability.
- The courts connect the judicial, law enforcement, and treatment communities with other systems through comprehensive case management to address participants' needs, such as education, housing, job training, and mental health.
- These intensive programs help participants recover from addiction and aim to prevent future criminal activity while also reducing the burden and costs of repeatedly processing low-level, non-violent offenders through courts, jails, and prisons.


